- 1. Adopter shall ensure this dog has a loving home, shall provide food, fresh water, adequate exercise and human affection.
- 2. Adopter shall provide shelter at all times in a secure confinement area when the dog must be unattended. Adopter understands and agrees that an 'invisible fence' does not constitute a secure area unless a responsible person is in the same area and actively managing the dog.
- 3. Adopter shall allow this dog to sleep inside the house.
- 4. Adopter shall protect this dog from potential injury and death by keeping this dog on a leash at any time it is outside of a securely fenced area.

- 5. Adopter shall not use a choke type collar at any time. Adopter shall use a front clip type collar. WTWTAR recommends SENSE-ation, EasyWalk, Walk/Wag, 2 Hounds Freedom Harness, or Halti collars or harnesses. If your dog backs out of regular collars, Adopter may use a Martingale limited slip collar.
- 6. Adopter shall never tether the dog while unaccompanied, nor to confine the dog in a way that causes the dog to suffer.
- 7. Adopter shall never allow the dog to ride in the open bed of a pick-up truck.
- 8. Adopter shall keep this dog at a healthy, proper weight and provide veterinary treatment when needed, including all vaccinations, heart-worm and flea and tick preventatives, diagnostic and preventative medical tests, and medications and treatments required to maintain overall good health.

 - Your preferred veterinary location choice from the above list. A WTWTAR volunteer will send you a spay/neuter voucher for your clinic of choice. WTWTAR pays only for the spay/neuter surgery and pain medications. WTWTAR does not pay for pre-surgery blood work or E-collars. These costs will be the Adopters responsibility if elected. If the WTWTAR voucher is not presented at the time of the procedure Adopter will be responsible for all charges. If Adopter prefers the surgery be done by their veterinarian, WTWTAR will reimburse Adopter up to but not exceeding the cost charged by our veterinarians. This cost currently is \$75.00 for spays and \$65.00 for neuters. Documentation will be required for all spays and neuters NOT performed by the veterinarians listed above.
- 10. Adopter shall keep this dog groomed, clean, free of matting of the dog's coat, and free from fleas, ticks, and other parasites.
- 11. Adopter shall ensure this dog wears the provided WTWTAR tag as well as Adopter's own identification tag at all times.
- 12. Adopter shall notify WTWTAR within 24 hours if this dog should become lost or stolen.

- 13. Adopter shall notify WTWTAR of his or her new street address, email address, and phone numbers within 30 days of the change of that information. Adopter shall also notify the Microchip company of his or her new addresses and/or phone numbers within 30 days of the change in information.
- 14. Adopter shall comply with all State and Local Laws and Ordinances which pertain to the ownership of this dog including but not limited to vaccinations and leash laws.
- 15. Adopter shall never allow this dog to be used for dog experimentation of any kind, dog fighting, or guard duty. _____ Adopter to initial
 16. Adopter shall never give, sell, or cause this dog to be given or sold to any agency, Humane Society,

- 18. In the rare event the Adopter is unable to care for the dog, the Adopter shall contact WTWTAR to discuss approved viable options which shall include but are not limited to behavior modification training and/or rehoming options. The Adopter recognizes and agrees that adopting a dog is a lifelong commitment and by adopting the dog, the Adopter is committed to the love and care of the dog by acting in its best interest at all times. Any behavior issues should be discussed with WTWTAR as soon as they develop as we may be able to help avert a negative outcome for the dog and the Adopter. In the event all viable options have been extinguished, WTWTAR will evaluate the possibility of taking the dog back into its adoption program providing Adopter acts as foster for the dog until such time as he/she is adopted.
- 19. Adopter shall complete an approved dog training class with this dog within six months of the date of this contract. Approved classes are reward based obedience training programs with a certified CCPDT trainer. CCPDT trainers can be found at http://www.ccpdt.org/index.php?
 option=com_certificants&Itemid=102. WTWTAR also has recommended trainers on our website if you are local to the Triangle Area. These trainers can be located on the "Information" section of our website. The adopter may ask a WTWTAR Representative to approve a trainer not already listed as well.
- 20. Adopter shall have the dog examined by Adopter's veterinarian within two to four weeks of the adoption date. The examination shall include but not be limited to heart-worm prevention prescription, provide medical records received from WTWTAR to Adopter's vet so that vaccination dates will be known by new vet and to establish the dog's relationship with his or her new veterinarian.
- 21. Adopter shall be responsible for all costs incurred for the dog post adoption (including but not limited to veterinarian costs, monthly heart-worm preventative medication, and flea and tick prevention).
- 22. Adopter shall pay the non-refundable adoption fee set forth at the end of this contract.
- 23. A twenty-five dollar (\$25) service charge will be charged to Adopter on any returned checks to WTWTAR issued by Adopter. Adopter shall have no more than two (2) weeks to pay the service charge and the full adoption fee.
- 24. WTWTAR reserves the right to schedule a follow-up visit and to ascertain that all conditions of this adoption contract are being upheld.
